### What is the Accreditation Process, and What is the Cost?

Requirements for program accreditation can be found on [www.NASBITE.org](http://www.NASBITE.org). There are different requirements for training organizations and for colleges/universities. The application and supporting documentation must be completed and submitted to NASBITE International, along with a non-refundable application fee. This application fee is applied to the Program Accreditation fee upon approval of the application. Accredited Training Programs pay a fee of \$400 per year to maintain the accreditation.

### Accreditation Period

Program accreditation is valid for three years. To continue as an Accredited Training Program, a continuance application and documentation is required.
